Publication Calendar 2023 Sovereign, Sub-Sovereign and Supranational Ratings



This calendar sets out the potential publication dates for Scope Ratings GmbH's current sovereign, sub-sovereign and supranational ratings in 2023 in accordance with Regulation (EG) Nr. 462 from 21 May 2013 (an amendment to Regulation (EG) 1060/2009 on rating agencies).

As required by the EU CRA Regulation, all publication dates are on Fridays. The EU CRA Regulation allows credit rating agencies to deviate from their announced calendar dates where necessary but notes that deviations require a detailed rationale and should not happen 'routinely'.

This calendar does not incorporate dates where Scope Ratings are derived exclusively by reference to an existing credit rating of a programme, category/class of debt or the primary rated sovereign, sub-sovereign or supra-national entity. This includes for example the assignment of credit ratings to debt instruments of the same seniority as previously rated debt issued by frequent government issuers.
